

Cooper Tea Company Giveaway Rules & Regulations  
Sweepstake

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This Sweepstake is open only to those who comment on the Facebook or Instagram post and who are 18 years or older as of the date of entry. The Sweepstake is only open to legal residents of the United States of America, and is void where prohibited by law. Employees of Cooper Tea Company, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Sweepstake. The Sweepstake is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Cooper Tea Company. You may enter only once. You must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules.
